Terms and Conditions:

1. Konfident Kids is a division of Accent Health Sciences, which are both trading names of De Paoli Consulting Pty Ltd.
2. Konfident Kids (KK) Parties are available for children aged 5 – 12 years.
3. KK Parties are held at your home, or a venue of your choice.
4. A 30% non-refundable deposit must be paid to confirm your booking as early as possible. Failure to do so may result in your requested date and time being allocated to another party.
5. The remaining balance **must** be settled *before the day of the party*. Staff will not be sent to run your party if this payment is not received by at least the business day before your scheduled party.
6. Postponements within 72 hours of the party date may be subjected to a cancellation fee equivalent to the amount of the deposit paid. For a reason other than the poor health of the birthday child, proven by a medical certificate, it is up to the discretion of KK management in deciding whether or not the cancellation fee will apply.
7. The published cost of a KK party does not include the hire of indoor venues.
8. KK may be able to help you locate a suitable indoor venue in the suspected event of bad / wet weather. Extra costs will apply and will vary from venue to venue.
9. Any price quoted by KK in relation to point 8 above will be strictly at cost price. KK does not profit from the hiring of any suggested indoor venue.
10. In the event of wet weather, the decision whether or not to proceed with a planned outdoor party, will be made in consultation with the party organiser no earlier than the day before the party is scheduled to run. KK will reschedule your party at no extra cost to you and will endeavor to provide you with an alternate date and time of your choosing.
11. Notification of final numbers attending **must** be received one week before the set party date, with the names of guests supplied to staff.
12. The cost of children unable to attend the party on the day *will not be refunded*.
13. The party organiser is responsible for their guests before and after the party.
14. Where the party is scheduled to take place at a public venue, at least two adults, identified at the time of booking must be available to supervise the children at all times during the party. KK will not be responsible for any child that leaves the party at any stage during the event.
15. An *activity and games plan* will be sent to the party organiser one week prior to the event for approval. If the party organiser does not provide feedback on this plan, KK will assume that consent to follow the plan, has been given.
16. KK reserves the right to make any changes to the activity and games plan that is deemed necessary to ensure the most successful outcome. Such changes may be triggered by (but are not limited to) weather, venue hazards & restrictions, guest numbers & age and ability levels.
17. KK reserves the right to request the removal from the party, any child causing significant disruption or safety risk to themselves or other guests. If the request is refused, KK reserves the right to terminate the party.
18. The 2 hour party includes scheduled breaks for drinks and snacks.
19. KK does not supply any food or drinks. These are to be supplied and provided by the organiser
20. Disclaimer: Sporting activities require physical exertion and include inherent risk of injury and / or death. Participation by your child or children, is your acceptance of that risk, on their behalf. KK will not accept liability for the injury or death of any child at a KK party.
21. Notwithstanding, KK is committed to safety and will:
 - I. Provide at least one host with a current First Aid Certificate,
 - II. Endeavor to find out relevant health information pertaining to the birthday child and his / her guests.
 - III. Make any changes necessary to the *activity and games plan* as required, as a result of point II. above.
 - IV. Reserve the right to restrict or prohibit the participation of any child believed to be at risk as a result of point II. above.
 - V. Ensure that all activities planned have been checked against a thorough safety checklist.
